Annual Parish Meeting at 5pm on Monday 15th May 2023

The Annual Parish Meeting is not a council meeting. It is a meeting of the parish electors and usually takes place between 1 March and 1 June. In practice these meetings celebrate local activities and provide residents in the community an opportunity to meet their Councillors.
